# NEWEST HOSPITAL, BY THE NUMBERS

## VISION 2017

The new hospital is just one step toward PinnacleHealth's goal of having its services in easy proximity to residents of Cumberland, Dauphin and Perry counties. Other steps include adding three patient floors at its Community General Osteopathic Hospital and, at Harrisburg Hospital, adding a cardiothoracic intensive-care unit and converting to private rooms.

**W**ith an opening date of May 19, West Shore Hospital is officially the newest health care facility in the area.

Part of the Harrisburg-based PinnacleHealth System, it is located at 1995 Technology Parkway in Hampden Township, Cumberland County, near PinnacleHealth's Fredricksen Outpatient Center.

Highlights of the hospital's design include copious natural light, bathrooms designed to reduce the risk of falls, and a digital whiteboard in each room so providers can inform and update patients about their care while minimizing disruptions. ■

## TIMELINE

**PAST:** The last hospital to open in the area was the \$207 million Penn State Hershey Children's Hospital in January 2013. It has six stories and 72 inpatient rooms and is right beside Penn State Hershey Medical Center in Dauphin County.

**FUTURE:** The 100-bed Memorial Hospital in York was acquired by Community Health Systems Inc. in 2012, and the sale agreement included a commitment to build a replacement hospital in West Manchester Township on the site of a former golf course near Route 30. At the time, construction was slated to begin sometime this year, but according to township officials, no preliminary plans have been submitted yet, and there has not been any action on the project for months.

# Two sides to the Marketplace Fairness Act: an examination

John Moesta thought he did everything right.

The Hampden Township businessman used \$75,000 of his own money to build his e-commerce company Dull Knife Terminator Inc. from about

\$30,000 in sales in its 2010 opening year to more than \$1 million in sales in 2013. Through the first four months of 2014, he's on track for \$1.2 million in sales this year.

As promising as that sounds, the Marketplace Fairness

Act of 2013 could put him out of business.

"I'll fold immediately" if the law passes through U.S. Congress, he said. "I know I can't do what they're telling me I'll have to do."

Moesta and about 40 other small, e-commerce businesses stormed Washington, D.C., in late April to make

sure lawmakers knew exactly how the proposed law, which passed through the Senate in 2013, would affect them.

The Marketplace Fairness Act would require customers of e-commerce businesses to pay local and state sales tax on their purchases. E-commerce
